- By repeatedly accessing the system or sharing the access with others.
- The use of 'gross forwarding' to gain access to systems.
- The use of denial of service attacks or social engineering.

### What do we do when we report responsible disclosure?

Have you reported a vulnerability in our ICT system? Then we deal with this as follows:

- If your report meets the above conditions, we will not attach any legal consequences to this report.
- We will treat your report as strictly confidential and will not share any personal details with third parties without your permission, unless this is required by law or a court ruling.
- The NCSC will send you a confirmation of receipt within 1 working day.
- The NCSC will respond to your report within 3 working days with an assessment of the report and an expected date for a solution.
- The NCSC will keep you informed of progress. We will solve the security problem you have identified in a system within 60 days at the latest. In mutual consultation, we will determine when and how we will publish the report.
